Avoid purchasing high premium insurance policies to save tax



From **1st Apr 2023**, maturity proceeds on fresh insurance policies bought with aggregate premiums above **Rs 5 lakhs** would be taxable



Hence there is a **push to sell these insurance policies** before **31st March**



Avoid these as the returns from these policies are very low
